## **Upcoming National Board Part III Exam Changes**

The NBEO was established in 1951, and is an independent, nongovernmental, nonprofit organization whose examinations are universally accepted for optometric licensure in the United States and accepted internationally. Its mission is to protect the public by developing, administering, scoring, and reporting results of valid examinations that assess competency in optometry.

The Board uses the following NBEO examinations:

- Part I Applied Basic Science.
- Part II Patient Assessment and Management.
- Part III Clinical Skills.
- Treatment and Management of Ocular Disease (TMOD).

The NBEO Part III exam—currently called Clinical Skills—will have a new title and, effective August 2024, will be named the Patient Encounters and Performance Skills (PEPS) exam.

The Part III exam had been developed to not only evaluate essential skills, but also to measure a candidate's ability to apply evidencebased knowledge to patient care. The new exam moves beyond the assessment of the physical ability to perform the skill to also measure a candidate's cognitive ability to interpret the result and apply that knowledge directly to patient care.


Registration for the next NBEO Part III PEPS examination opened on Tuesday, March 26, 2024.

## Board Encourages Optometrists to Take Continuing Education Courses on Diversity, Equity, Inclusion, and Belonging

The Board is committed to DEIB and embedded its commitment into its values within the amended Strategic Plan, adopted on February 16, 2024. One of the Board's Outreach goals contained in the Strategic Plan is found at Goal 5.7: "Evaluate and create better consumer outcomes such as access to care and addressing patient needs for marginalized populations by implementation of a multi-step action plan educating licensees about concepts of diversity, equity, inclusion, and belonging." Today, the Board takes yet another step toward fulfilling that goal by releasing a Board/staff researched list of continuing education courses in DEIB. Our previous efforts to educate licensees about concepts of DEIB have included:

- August 26, 2022—A presentation on DEIB by Dr. Ruth Shoge, O.D. (director of DEIB and associate clinical professor, Herbert Wertheim School of Optometry and Vision Science at the University of California, Berkeley).
- August 25, 2023—Board action to seek a legislative proposal to encourage optometrist licensees to take CE courses in DEIB.
- December 8, 2023—Strategic planning session embedding DEIB into our 2021–2025 Strategic Plan.

Please note that this is a non-exhaustive list based on Board/staff research. The Board is not responsible for the courses and does not endorse any course beyond indicating whether it qualifies for CE requirements or not. All these courses meet current Board CE requirements by virtue of being COPE (Council on Optometric Practitioner Education) approved or approved by another CE provider authorized by Board laws. ## Donate Your Used Eyeglasses and Give the Gift of Sight

Vision is an essential part of daily life. Poor vision can negatively affect a person's independence, cognition, and mental health, while increasing the risk of injury. Yet, many people around the world do not have access to the vision care they need, including access to eyeglasses. This is where eyeglass donations come into play. Donating used eyeglasses can make a significant difference in the lives of individuals who cannot afford them on their own, and by helping to improve their vision, help them regain their independence and improve the quality of their lives.

#### The Need for Eyeglasses

According to the World Health Organization, approximately 2.2 billion people worldwide have a vision impairment or blindness, and at least 1 billion have a vision impairment that could have been prevented or has yet to be addressed. In California, millions of people do not have access to vision care, and children, the elderly, and historically marginalized and underrepresented populations are disproportionately impacted. Many of these individuals live in settings where access to eye care services is limited or non existent. The donation of used eyeglasses could help address this need.

#### The Impact of Eyeglass Donation

Donating eyeglasses is a simple act that can have a profound impact. Here's how:

- 1. **Improving Lives** Eyeglasses can dramatically improve the quality of life for individuals with vision impairments, enabling them to read, work, and live independently.
- 2. **Promoting Education** For children, having the right pair of glasses can significantly enhance learning and comprehension, leading to better educational outcomes.
- 3. **Boosting Economy** Adults who receive donated glasses can increase their productivity at work, potentially boosting the local economy.

#### How Eyeglass Donation Works

Organizations collect used eyeglasses and sort them by prescription strength. The glasses are then cleaned and repaired if necessary. These glasses are then distributed to individuals in need, either for free or at a very low cost.

The Board has found the following organizations specifically engaged in collecting and disseminating used eyeglasses. Click these links to learn more:

How do these programs work? Typically, the programs partner with locations to establish drop off boxes that collect used eyeglasses. For example, the Lions In Sight program, which has been operating for decades in California and Nevada, has more than 400 drop off locations, with most located in California. The boxes are periodically checked and must be delivered to a Lions In Sight affiliated drop off location or mailed to the Lions In Sight warehouse located in Vallejo. Lions In Sight publishes a list of more than 400 drop off locations, which can be accessed **online**. More than 95% of the locations are in California and donation boxes may be found at diverse places, including grocery stores, optometric colleges, and at many licensed locations across the state such as optometric offices and dispensing locations.

#### **Give the Gift of Sight!**

Eyeglass donation is a powerful tool in the fight against vision impairment. By donating your used eyeglasses, you're not just recycling an old item you're giving someone the gift of sight. So, the next time you get a new pair of glasses, consider donating your old ones. It's a small act of kindness that can make a world of difference.

## Subject Matter Expert Recruitment for Exam Workshops and Expert Witnesses

Would you like to earn up to **12 CE hours per renewal period**, get paid up to \$200 per day, and give back to your profession? Become a Board subject matter expert (SME)! The California Laws and Regulations Examination (CLRE) taken by new optometrist applicants is developed by SMEs. Join us to help ensure that the CLRE accurately reflects the tasks and knowledge required to practice in California. All travel, hotel, and meal expenses are reimbursed at the state rate!

Exam development not your thing? The Board also needs expert witnesses to assist the Enforcement Program in protecting consumers of optometric services. An expert witness is any licensee possessing technical or professional knowledge gained from advanced education and/or extensive work experience that enables the individual to form a definite opinion in an area of expertise in the standard of care for the profession. Expert witnesses are asked to review confidential case material, prepare written reports, and possibly testify at administrative hearings. Their reports and/or findings may result in a disciplinary action against an optometrist. The Board pays experts at the rate of:

- \$100 an hour for record review and preparation of a written report.
- \$150 an hour for testimony at a hearing.




To participate, all licensees must:

- Hold a current active license with a glaucoma certification and be practicing in California.
- Be in good standing with the Board.
- For Exam Development SMEs: Newly licensed optometrists within five years of graduation are highly encouraged to apply!
- For Expert Witness SMEs: Licensed optometrists with technical and professional expertise demonstrating ability to form expert opinions about the standard of care in optometry.

## California Law and Regulations Exam Information Bulletin Updated!

The Board is thrilled to announce the release of the **2024 California Law and Regulations Candidate Information Bulletin** (CIB). The CIB is provided to every exam candidate and includes helpful information about testing development, test locations, and instructions for taking and completing the exam. The 2024 CLRE CIB contains working links to the laws and regulations that candidates will need to know to successfully pass the exam. For the first time, the Board is publishing sample questions with an answer key, one from each content area assessed on the exam, to assist applicants in their exam preparations. ## **Options Available to Optometrist Licensees When Ceasing Practice**

#### WHEN YOU OBTAIN DELINQUENT STATUS:

- You are not allowed to practice.
- Delinquent Status is obtained by not renewing your license on time.
- License will automatically cancel after three years.
- License can return to Active Status after meeting the following requirements:
  - » Paying required fees and any delinquency fees.
  - » Providing proof of CE compliance (if less than three years in delinquent status).
  - » Taking and passing the CLRE and NBEO Clinical Skills Exam (if more than three years in delinquent status).
  - » Requirements may vary if you have an active license in another state.

Authority cited: Business and Professions Code (BPC) §§ 3040, 3147, 3147.6, 3147.7, 3152.

#### WHEN YOU OBTAIN INACTIVE STATUS:

- No practice allowed.
- Cannot indicate you have an active license.
- Can be selected on your regular license renewal.
- Must be renewed every two years.
- No CE is required for inactive status renewal.
- Renewal fee is the same as an active license.

License can return to active status with proof of CE compliance and payment of renewal fee, if due.

Authority cited: BPC §§ 700 704.

#### WHEN YOU OBTAIN RETIRED STATUS:

- No practice allowed.
- Can only use the titles "retired optometrist" or "optometrist, retired."
- Obtained by submitting **an application** and \$25 fee available on BREEZE.
- Cannot be renewed.
- License can return to active status after meeting the following requirements:
  - » Pay required fees and any delinquency fees.
  - » Provide proof of CE compliance (if less than three years in Retired Status). Take and pass the CLRE and NBEO Clinical Skills Exam (if more than three years in Retired Status).

#### Authority cited: BPC §§ 3151 3152.

## WHEN YOU OBTAIN RETIRED VOLUNTEER STATUS:

- Can practice on an unpaid basis only and only at health fairs, visions screenings, and public service eye programs.
- Obtained by submitting **an application** and \$50 fee available on BREEZE.
- Must be renewed every two years.
- Renewal fee is \$50.
- Continuing education is required for renewal.
- License can return to Active Status after meeting the following requirements:
  - » Pay required fees and any delinquency fees.
  - » Provide proof of CE compliance (if less than three years in Retired Volunteer status).

# Optician Training Programs in California

Here in the Golden State, individuals interested in pursuing a career in opticianry have a variety of educational opportunities. The Board's Optician Program has four license types:

- **Registered Dispensing Ophthalmic Business**—For businesses that offer the fit and adjustment of spectacles and/or contact lens and fulfill prescriptions for ophthalmic devices ordered by optometrists or physicians and surgeons.
- **Registered Spectacle Lens Dispenser**—For those who have passed the American Board of Opticianry Exam and wish to work in dispensing optical shops.
- Registered Contact Lens Dispenser—For those who have passed the National Contact Lens Examiners exam and wish to work in dispensing optical shops.
- **Nonresident Ophthalmic Lens Dispenser**—For businesses outside of California that ship ophthalmic lenses to consumers within the state.

## **Apply for an Immunization Certificate**

Licensed optometrists in California are authorized to administer certain immunizations and order laboratory tests if the following requirements are met:

- Hold a TPA certification.
- Complete an immunization training program endorsed by the CDC or Accreditation Council for Pharmacy Education. Read more by clicking **here**.
- Complete an application for an immunization certificate on a board approved form and pay the fee of \$50. Now on BREEZE!

Optometrists holding an immunization certificate can administer immunizations for the following viruses:

• Influenza, herpes zoster virus, pneumococcus, and SARS-CoV-2 (COVID-19).
