New Board Officers Elected

Every year the Board must elect from its members a president, vice president, and secretary charged with assisting the Executive Officer in facilitating the functions of the Board. The Board began the nominating process earlier this year and elected new officers at the May 31, 2024, public board meeting, for one-year terms effective July 1, 2024. Culturally Competent Care: Latinos en Optometry

Latinos en Optometry seeks broader representation of Latinos and Spanishspeaking professionals within optometry

Health care professionals are ethically and professionally obliged to provide the best possible care that supports the health and well-being of all patients, irrespective of personal identities and characteristics.

Patients and health care providers bring to the table a wide cross-cultural array of clinically relevant needs, attitudes, customs, values, beliefs, preferences, assumptions, expectations, practices, and fears that decode experiences, shape perspectives, affect decisions, and drive behavior.1

To achieve optimum vision and eye health for everyone, it is important for optometrists, opticians, optical staff, and optometry students to understand how diversity influences care and affects outcomes.



Latinos/Hispanics and Eye Care

The Latino/Hispanic community continues to grow as a percentage of the U.S. population.

The Census Bureau estimates there were roughly 63.7 million Hispanics in the U.S. as of 2022, a new high. Hispanic people represent more than 39 percent of California's population. They represent up to 19% of the nation's population,² and according to U.S. Census Bureau projections, Latinos are expected to be 21% by 2030.3 By 2040, one of every four Americans will be of Latin-American culture.4

Yet, Latinos are not represented in the health care workforce at rates comparable to their share of the general population. With respect to Optometry:

- Currently, only 5.2% of U.S. optometrists are Latino, according to research from the career resource site Zippia.⁵ (In California, Hispanics make up less than 6% of licensed optometrists.⁶)
- For the 2023–2024 cycle, the Optometry Centralized Application Service (OptomCAS), a service of the Association of Schools and Colleges of Optometry (ASCO) shows a decline in the number of Hispanic/Latino applicants to U.S. schools of optometry from the previous year.

Diversity Awareness and Cultural Competence in Optometry

According to the National Eye Institute, the Latino population has some of the highest rates of eye disease and visual impairment caused by eye diseases like diabetic retinopathy and glaucoma, and a significant number may be unaware of their eye disease.⁷ In a study conducted by The Associated Press-NORC Center for Public Affairs Research,8 more than half of Hispanic adults say they have encountered a communication barrier in the health care system, and they turn to a variety of formal and informal sources for help in overcoming these obstacles.

"These and other findings demonstrate an ever-increasing need for Latino (and Spanish-speaking) doctors of optometry, opticians, and other eye care professionals," says Latinos en Optometry cofounder Diana Canto-Sims, O.D. In 2021, Dr. Canto-Sims, founder of Buena Vista Optical, a fully bilingual eye care clinic and eyewear boutique in Chicago, and Lawrence Chavez, founder and CEO of EveryDay Contacts, Inc., founded Latinos en Optometry with goals of increasing the number of qualified Latino students applying to optometry schools, helping eye care professionals deliver eye health care in a culturally mindful manner, and generating greater public awareness and understanding of the need for eye care among the Latin American population.

"A preponderance of scientific evidence supports the importance of increasing racial and ethnic diversity among health care professionals," says Dr. Canto-Sims. "Greater diversity among health professionals is associated with improved access to care for racial and ethnic minority patients, greater patient choice and satisfaction, better patient-provider communication and better

educational experiences for all students in training. Furthermore, it is important for non-Latino health care providers to improve their Spanish language communication skills, especially if practicing in areas where most of the patient population speaks Spanish and/or has limited English proficiency."



Membership in Latinos en Optometry is free to all students interested in a career in Optometry or related eye care professions, those currently enrolled in a certified college of optometry, allied health profession, education, and rehabilitation program or in an optometric residency or a fellowship program. All 2024 memberships run through December 31, 2025. The group's website (**www.latinosenoptometry.org**) features information and resources for prospective and current optometry students, including a series of archived and upcoming free webinars, supported by Transitions Optical, in which Latinos en Optometry Board members share their experiences and offer advice to support and inspire students to consider a career in Optometry. "We need to expose more students to potential careers in Optometry so they can see how it might fit into their passions, interests, skills, and lifestyle and career aspirations," says Howard Purcell, O.D., FAAO, president and CEO, New England College of Optometry and one of the cofounders of Latinos en Optometry.

"We are so pleased that the California State Board of Optometry shares Latino en Optometry's commitment to helping current and future eye care professionals deliver eye health care in a culturally mindful manner through ongoing education and resources," says Dr. Canto-Sims. "Diversity and cultural competency are strengths and assets that will help us create a future with more quality and equitable eye care experiences and healthier outcomes for all."

Fee Increase Effective July 1, 2024

In 2023, the Board enacted regulations to increase most application, licensing, registration, and

2023, but the Board delayed the implementation until July 1, 2024, providing time for the Board's systems to be updated and for applicants and licensees to have sufficient foreknowledge of the increase. Board Releases Regulations to Increase Access to Care

The Board recently released two proposed regulations now out for public comment. The **Home Residence Permit Program** was released for 45 day public comment on July 19, ending September 3, and the proposal would help expand access to eye care to the homebound, enabling underserved or vulnerable populations to receive comprehensive eye care within the comfort of their own residence, while also providing consumer protection, by having a way to track licensees working out of the home via the issuance of a permit.

The second proposal, released on August 9 for a 45 day public comment period ending September 23, would authorize optometrists to use **Radio Frequency Technology or Devices** when treating dry eye syndrome. Expanding the allowable noninvasive treatment options that an optometrist can use to treat dry eye will positively benefit Californians who are suffering from dry eye disease. As patients suffering from this condition have their symptoms alleviated, their quality of life should also improve.

New National Board Part III Exam is Live

The National Board of Examiners in Optometry (NBEO) Part III exam, previously called Clinical Skills, effective August 2024, is now the Patient Encounters and Performance Skills (PEPS) exam.

The Part III PEPS exam was developed to not only evaluate essential skills, but also to measure a candidate's ability to apply evidence-based knowledge to patient care. The new exam moves beyond the assessment of the physical ability to perform the skill to also measure a candidate's cognitive ability to interpret the result and apply that knowledge directly to patient care.

Wear Sunglasses to Protect Your Eye Health

CSBO Exam Vendor Updates Testing Platform with New Accessibility Tools

The Board utilizes an exam vendor to administer the California Law and Regulations Examination that all optometrist applicants must successfully pass. Beginning in mid August 2024, the Board's exam vendor, PSI, has enhanced their testing delivery system. The new delivery system provides several reasonable accommodation enhancements. Five new accessibility features are now available:

- Magnifier: the magnifier tool shows text at twice the size of the original content. When enabled, an option is added into the Tools menu to provide the candidate the opportunity to magnify the page content. When launched, a magnifier box appears over the page content. The text within the magnifier box will be twice the size of the original content.
- Contrast selection: The contrast selection tool shows different contrast options available to the test taker. Selecting a high color contrast will show a darker border around the page. Test takers will also be able to select high color contrast inverted which will invert the page background to black with white text.

- Keyboard shortcuts: Test takers will be able to access keyboard shortcuts, which will display on their screen a variety of different keyboard shortcut options to assist the test taker access the exam.
- Comment button: Test takers will have the ability to provide comments and feedback on one or more questions within the exam.
- Index button: Test takers will have the ability to see a list of all questions in the exam. This enables the test taker to navigate to a specific question, see questions that are unanswered, or questions the test taker may have flagged to come back to.

Beginning in August, all test takers will first have access to a tutorial of these features before they begin the exam. Please contact the Board via email at

We Need You! Subject Matter Expert Recruitment

Would you like to earn up to 12 CE hours per renewal period, get paid up to \$200 per day, and give back to your profession? Become a Board Subject Matter Expert (SME)! The California Laws and Regulations Examination (CLRE) taken by new optometrist applicants is developed by SMEs. Join us to help ensure that the CLRE accurately reflects the tasks and knowledge required to practice in California. All travel, hotel, and meal expenses are reimbursed at the state rate.

Exam development not your thing? The Board also needs expert witnesses to assist the enforcement program in protecting consumers of optometric services. An expert witness is any licensee possessing technical or professional knowledge gained from advanced education and/or extensive work experience that enables the individual to form a definite opinion in an area of expertise in the standard of care for the profession. Expert witnesses are asked to review confidential case material, prepare written reports and, possibly, testify at administrative hearings. Their reports and/or findings may result in a disciplinary action against an optometrist. The Board pays experts at the rate of:

- \$100 an hour for record review and preparation of a written report.
- \$150 an hour for testimony at a hearing.

To participate, all licensees must:



- Hold a current active license with a glaucoma certification and be practicing in California.
- Be in good standing with the Board.
- For exam development SMEs: Newly licensed optometrists within five years of graduation are highly encouraged to apply!
- For expert witness SMEs: Licensed optometrists with technical and professional expertise demonstrating ability to form expert opinions about the standard of care in optometry.
