Dr. Ross requested an agenda item that came before the Board during the last Board meeting concerning the ARBO OE Tracker system. During the August 26, 2022 Board meeting, Members discussed the idea of possibly being able to link the ARBO OE Tracker system with the Board’s BreEZe system. Dr. Ross understood that the next step in this process would be to set up a meeting with the BreEZe IT team.

Dr. Ross requested another item which was discussed at the end of the August 26, 2022 Board meeting. During a presentation from the professor at the California Berkeley School of Optometry, Dr. Ruth Shoge recommended that the Board look further into allowing Diversity, Equity, Inclusion, and Belonging (DEIB) continuing education (CE), and for this to be made a requirement for California optometrist CE requirements. Dr. Ross would like to have a discussion on the logistics of making DEIB a CE requirement for California optometrists.

Mx. Love explained that there may not be sufficient time to obtain enough information for placing these two items on the November agenda. The items may need to be included in an

agenda for early next year. They assured Dr. Ross that they will do their best to get these agenda items as quickly as possible.
