Subject: Agenda Item 8 – Update, Discussion and Possible Action Regarding Proposed

Occupational Analysis and Audit of the American Board of Opticianry

Examination and National Contact Lens Examination; Recommendation to Full

Board

The DOC raised concerns at its August 2017 meeting regarding the current American Board of Opticianry (ABO) examination and the National Contact Lens Examination (NCLE) and the relevance to California spectacle and contact lens applicants/registrants.

As a result, the DOC directed staff to work with DCA's Office of Professional Examination Services (OPES) to obtain an occupational analysis (OA) proposal for DOC consideration at its September 2017 meeting. While an option for a modified OA was discussed – due to the smaller registrant population, OPES' research showed the need to conduct full occupational analyses.

The cost breakdown for OPES to conduct an OA and national review for SLDs and CLDs is as follows:

Spectacle Lens Dispenser (SLD) Occupational Analysis Estimated Cost: \$52,848 Review of National Exam (ABO) and Linkage Study Estimated Cost: \$27,920

Contact Lens Dispenser (CLD) Occupational Analysis Estimated Cost: \$52,848 Review of National Exam (NCLE) and Linkage Study Estimated Cost: \$27,920

Note that the estimates **do not** include the cost of Subject Matter Expert (SME) honorarium and travel expenses.

After researching the programs, OPES determined that a standard occupational analysis (OA) is recommended, including a survey of practitioners. Our recommendation takes into consideration that there are approximately 3,000 spectacle lens dispensers and 1,200 contact lens dispensers; and that we have determined that there is minimal overlap in scope of practice between the two professions. In addition, this approach will best support the Board using outcomes from the OAs and national reviews for potentially changing license requirements.

OPES is proposing to perform the SLD OA and National Review in FY2018/19; and the CLD OA and National Review in FY2019/20. We do not believe there would be a cost saving to conducting both projects at the same time. In addition, the current proposal streamlines the SME recruitment efforts needed in that the Board would be recruiting SMEs for one license category at a time
