## **Applications**

Processing time for initial application review has increased to 8 weeks after the loss of the Board's Opticianry Registration Technician.

## <u>Staff</u>

The Board is currently recruiting a new Opticianry Registration Technician. The processing of Opticianry program applications is being divided between the Lead Licensing Analyst and the Licensing Support Technician.

## <u>BreEZe</u>

In November, changes were implemented in BreEZe that have greatly decreased the number of deficient applications. Also in November, two new applications were added for Opticianry BreEZe users: the application to change your name on your registration, and the application to update your registration's relationship to other registrations.

## ABO-NCLE Exams

The American Board of Opticianry and National Contact Lens Examiners (ABO-NCLE) continue to offer testing monthly. At this time, there has been no announcement indicating when testing will return to a quarterly schedule.

## Fiscal Year 20/21 Quarter 1-3

Enforcement staff has achieved the following between July 1, 2020 and March 31, 2021:

- Opened 65 Opticianry cases
- Closed 53 Opticianry cases
- Sent 3 Opticianry cases to the Attorney General's Office
- Took Disciplinary Action in 4 Opticianry cases
- Developed comprehensive procedure manuals for the tasks performed by enforcement staff
- Recruited, hired, and trained an enforcement technician

## **Disciplinary Actions**

The following Disciplinary Actions were taken against Opticians in the first three quareters of fiscal year 2020-2021, all four were based on criminal convictions.

## Trippi, Lisa Antoinette (SLD 6469) Redding, CA

Effective September 24, 2020, the registration of Lisa Antoinette Trippi (SLD 6469), with an address of record in Redding, CA, was voluntarily surrendered for a Conviction of a Substantially Related Crime (BPC §§2555.1, and 2559.3). <u>Click here to obtain a copy of the action or view the registrant's profile</u>

## Hall, Steven Wayne

Fig. 1: Opticianry Case Statistics, Q1-Q3, FY 2020-2021




Fig. 2: Opticianry Cases Received by Classification, Q3, FY 2020-2021




Fig. 3: Opticianry Cases Closed by type, Q3, FY 2020-2021

SUBJECT	Agenda Item #4D: 2021-2025 Strategic Plan Update						

In today's materials, members and the public received the final version of the <u>2021-2025</u> <u>Strategic Plan</u> as approved by the Board.

The Board has advised the DOC to monitor the following action plan objectives:

1.2 Explore the possibility of requiring continuing education for both spectacle and contact lens dispenser registrations to protect consumers and high application standards throughout licensure.

2.1 Consider the feasibility of developing a state law exam for opticians to verify their familiarity with California laws.

3.1 Advocate for the adoption of new opticianry statutes and regulations (using data from occupational analyses) that seek to clarify the principles of the profession and provide better consumer protection for those who are seeking opticianry services.

3.5 Monitor changes in federal law to identify methods that will strengthen existing California legislation regarding the sale of contact lenses and eyeglasses to improve enforcement and enhance consumer protection.

On March 5<sup>,</sup> and March 29, staff met to develop pre-action plans for each objective in the Strategic Plan. Another staff planning session is scheduled for Mat. Each of the plan objectives received individual review and development using the chart below.
