<b>SUBJECT</b>	Agenda Item #8A – Enforcement Program

The following Disciplinary Actions were taken against an Optometrist and Opticians that became final in the third quarter of fiscal year 2020-2021:

Narbae Vahik Avedian (OPT 15088) Effective January 6, 2021, the license of Narbae Vahik Avedian (OPT 15088), with an address of record in Studio City, CA was revoked, the revocation stayed, the license placed on probation for five years, and suspended for 30 days from the effective date for Conviction of a Substantially Related Crime, Dangerous Use of Alcohol, Action or Conduct Warranting the Denial of a License, and Violation of the Optometry Practice Act.

Nalbandyan, Ara (SLD 4222 and CLD 1263) Effective January 6, 2021, the registrations of Ara Nalbandyan, with an address of record in Glendale, CA, was revoked for the Unlicensed Practice of Optometry, Holding Oneself Out as an Optometrist, and Violations of the Optometry Practice Act.

Caliwag, Filip B. (SLD 6243) Effective January 6, 2021, the registration of Filip B. Caliwag (SLD 6243), with an address of record in Anaheim, CA was revoked for Criminal Convictions.

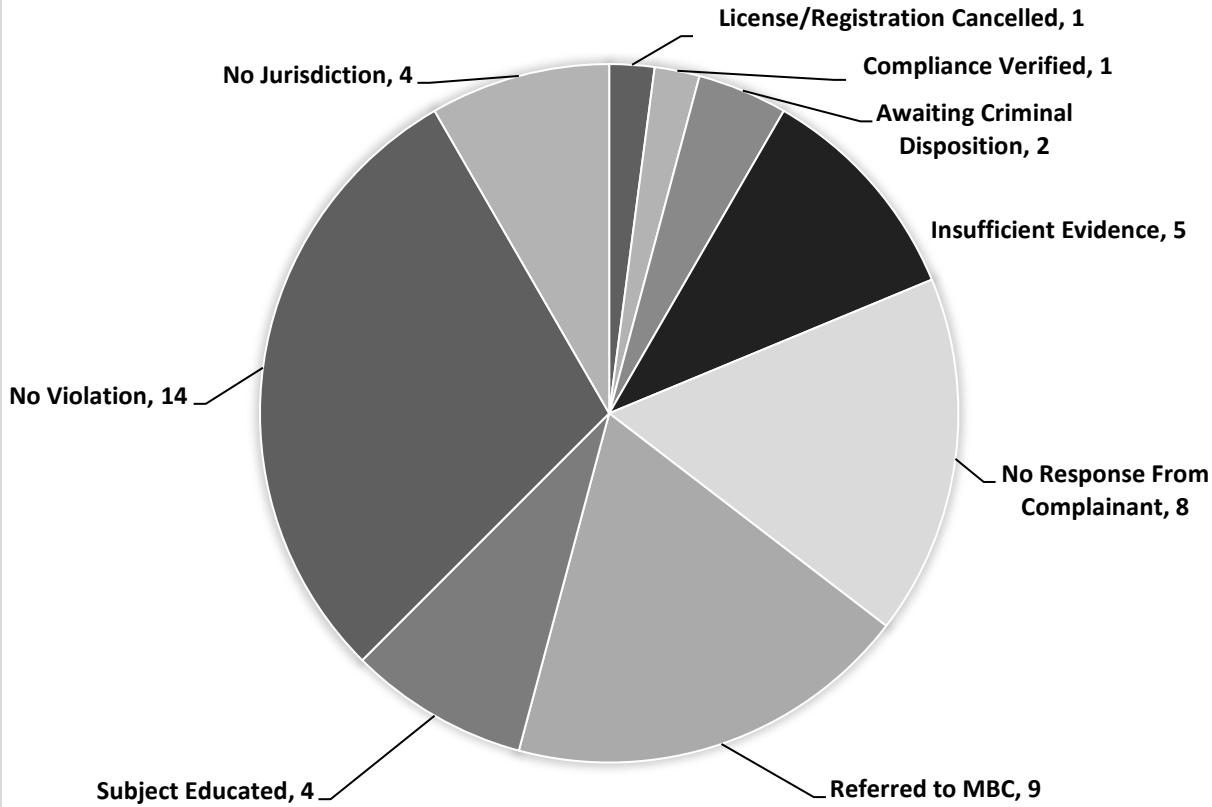

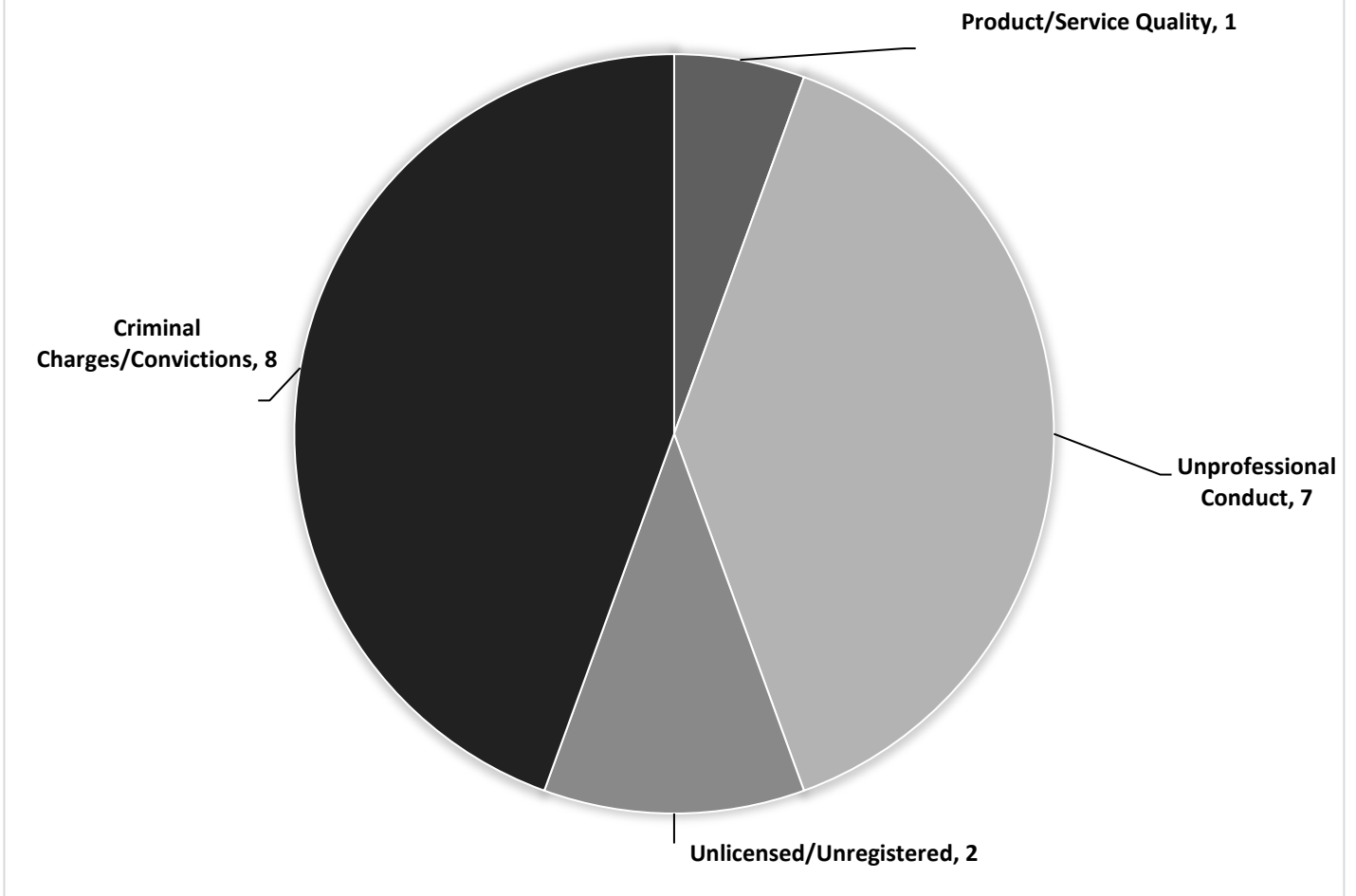
Agenda Item 8A, Chart 1 – Optometry cases received, quarter three, fiscal year 2020/2021

**OPTOMETRY CASES CLOSED - Q3, FY 2020/2021**



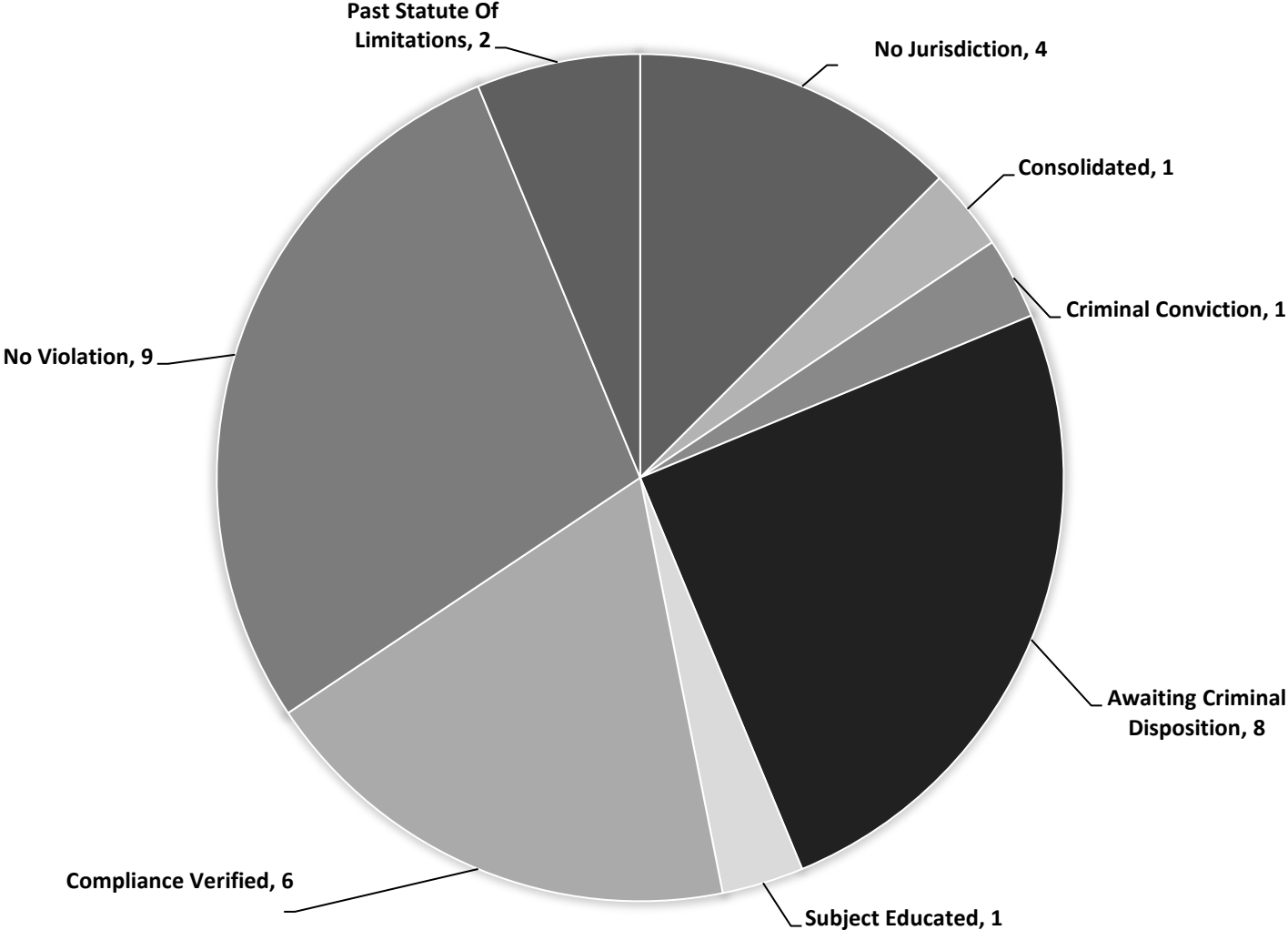
