Dr. Chawla explained that although the Board currently has an immunization certification application, it has not yet fully agreed upon a designation process. Therefore, she is not currently offering immunizations. Dr. Chawla has the experience to know that an optometrist

must wait for notification from the Board that their certification has been granted. She noted that others may assume "I submitted my application and check; the check was cashed; therefore, I am good to start offering immunizations". Additionally, the public has no way of determining who these optometrists are since the Board has not formally discussed and decided upon how to designate the immunization classification on the license.

Dr. Chawla stated that she and President Wang have briefly discussed the issue. Dr. Chawla suggested that the PEC offer up to the Board the designation of TGI since a licensee must already be certified for therapeutics prior to receiving immunization certification.

Lead Licensing Analyst, Natalia Leeper announced that she is the sole person handling the immunization applications. She explained that staff does have a plan and has not forgotten about this matter. She cannot discuss it in detail currently since it is not on the agenda. However, there is a plan to keep it along the same lines as the TLG designations and it is her understanding that this will be discussed at the March 11<sup>th</sup> Board meeting next week.
